- That no branch of this school shall run under continuing name of shanti Gyan International School as recognized school in Delhi or around Delhi by this society.
- That the change of name of the school shall be intimated to Registrar of Societies, GNCT of Delhi.
- That the members of the Governing Body are not in Govt. Service.
- That the society/management of the school shall be sole responsible for all litigations, if any, arising out of change of name.
- 9. All the liabilities whatsoever, of the existing school, shall be borne by the school with name changed.
- That changing the name of "Shanti Gyan International School" to "ORCHIDS The International School" will not
 amount to transfer of the school from one society to another society.
- 11. That by changing the said name, there will be no change in the Managing Committee of the school.
- That it is only change in the name of the school from "Shanti Gyan International School" to "ORCHIDS the International School" and the character of the school will remain unchanged.

13. That Directorate of Education, GCNT of Delhi will not be responsible for any dispute arising out of the change of

name of the school.
